Manual printing and mailing: time-consuming and pricey


In your organisation you regularly send a variety of information to your customers, employees and partners. Many of these documents contain particularly sensitive data that must be sent to the recip-ients securely. Sending them by email is quickly ruled out for various reasons. This process usually involves a great amount of manual effort in day-to-day work, combined with high printing, postal and processing costs.

Save yourself the effort: With d.velop postbox, you can easily deliver the relevant documents digitally to your customers, partners, employees or other recipients. Your recipients receive the information in their own free "online mailbox" and always have it directly to hand via the web or apps, without having to file the letters separately. For example, you can send your employees their payslips quickly and easily without having to print them out and send them by post. Delivery is encrypted. You do not need to check whether the document has been read and collected – unlike the usual portals.

How the delivery process works

When using the d.velop postbox, there is ja difference between the deliverer (company, organization) and the recipient. Recipients can be assigned to one or more senders. If recipients and deliverers are assigned to each other, the documents can be sent. The deliverer can send documents to recipients and recipients can send documents to the deliverer.

1. Generation of documents

The documents are still generated as usual in leading systems (e.g. SAP, DATEV, Loga, Sage HR, P&I LOGA, Microsoft Dynamics NAV, Lexware etc.). The sender has the option of using various DMS connectors or an output management system to prepare the documents for dispatch to the recipients. Different document types can be sent separately from each other via several services. (e.g. payslips, general terms and conditions, orders, information letters, annual financial statements, contracts, invoices, contribution notices, account statements, etc.)

2. Data delivery

The documents are transmitted to d.velop postbox in encrypted form, e.g. as PDF, XML or print stream. The documents are then processed in d.velop postbox using unique identifiers (e.g. personnel number) and delivered automatically.

3. Delivery and receipt of documents


Recipients have the option of deciding for themselves whether the documents should be received digitally or in analog form.

✓ Digital delivery

If recipients choose digital delivery, they receive a personal, free digital postbox and set it up individually. Documents are delivered digitally immediately. Recipients can access the documents immediately.

✓ Analog delivery


Documents can also be sent by post. On request, d.velop can take over the postal delivery to "non-digital" recipients.



Which documents can be sent using digital mail delivery?

A large number of documents can be delivered securely and in compliance with the GDPR via the d.velop postbox. These include in particular:

- ✓ Contract documents such as employment contracts, contracts with partners or customers
- ✓ **Invoices and payment requests** for the secure dispatch of financial documents
- ✓ **Relevant notifications** such as reminders
- ✓ Confidential information such as personal data of customers or employees that is subject to data protection regulations
- ✓ **Tax documents** such as tax returns or documents relating to inspections or audits
- ✓ Health data for example medical certificates or reports that are subject to special data protection requirements
- ✓ HR documents payslips and salary statements




